4. Declaration of Conflict of Interest

5. District 4 and Lanark Carleton Meeting Updates

- Non-checking will be in house league in **all** levels effective 2013-2014 season
- Online system for reporting suspensions is new this year should be better
- Proposed changes to social media policy did not go through
- There is now a "fine" system in place for lack of attendance at D4/Lanark Carleton meetings presidents can assign a delegate or two to represent the association in their absence
- There has been an overhaul of the OVSS board each association has appointed a rep; S7 voted to drop 2 teams; S7 will no longer offer 2 teams at the same level except for minor atom
- Lanark Carleton fees will be going up for \$140 from \$125

ODMHA-ODHA AGM

- Changes have been made to coaching clinics
- Head Coaches and assistant coaches MUST have Dev 1 to coach at the competitive level starting at minor PW (you no longer require coach stream to take Dev 1)
- Checking has been eliminated for major PW and below in house league
- ODHA has changed it's name Hockey Eastern Ontario, effective July 1st
- ODMHA has 883,000 registrations and is carrying a surplus of \$454,000
