#### 2. D4 + LCMHL Update - Ryan Goodwin

## LCMHL - Monthly Meeting

Jan 13, 2015

- a) Bank balance info provided, currently \$16,339, expenses to come out of Banners, Pro2col
- b) New web page design looks great, thanks Tom!
- Make sure Coaches are checking game sheet after games to confirm that they are correct, especially the penalties
- d) Glenn to check on PIMS, may have been some errors on the reports provided. SMHA seems pretty good. Midget B4 is tracking high. Tim has let them know and Christian is going to speak to the team. Minor Midget is high overall for all teams.

- e) Executive is going to look at whether Arnprior should be allowed back in Juvenile next year. Stacked team full of ex Jr. B players, very far for Osgoode to travel to. Not part of any other LCMHL divisions. They could play in one of the Sensplex leagues.
- f) A new forfeiture policy will come out for midget for games cancelled within 72 hours
- g) For new year looking to not schedule games for Major Midget during Jan exam week

### D4 - Monthly Meeting

- a) HEO not providing cert # on HCR
- b) Rep B Novice now not a pilot. Looks like most districts will have A, thus A should grow and Rep decrease in teams for Novice. OVSS looking to do Novice A x2
- c) HC age change, no change
- d) HEO looking at running house Novice as 4 on 4 vs. the current 5 on 5
- e) HEO voting has changed now 130 votes Minor hockey, 130 for Jr, 7 HEO Exec, total 267. Minor hockey players make up 97% of the membership. Hope this will change again with the new rules.
- f) John Reid (HEO RIC), make sure all handshakes are after the game vs. prior. Watch for rules in ODMHA tournaments that this is the case. Sensplex tournaments were having handshakes prior to the game.
- g) HEO looking at changing to a 2 man system vs. 3 man system for all house levels. This would change Peewee, Bantam and Midget that are currently 3 man systems.
- h) Walter Baker closing Aug 2015, this effects Nepean Minor Hockey as they current have 900 hours per season played out of this rink.
- i) D3 has a new hockey Prep School (like Rockland). They will not be sanctioned so will only play exhibition games.
- j) Assigning fees debate on whether the \$5.50 was a minimum or maximum. It is a minimum.
- k) Bell Sensplex is very slow in paying for Refs assigned from D4, \$15,000 receivable. This is an issue as money is tight as ref money is a breakeven.
- I) Ref pay roll will change to EFT starting in Feb, vs. current pay roll done by checks. Dec check should be ready by today.
- m) League GM being looked into for the refs assigning system.
- n) D4 needs to add an admin fee to assigning of refs to cover costs (Checks, EFT, Ink, office supplies, league GM, RIC mileage, phone, Ref evaluations, etc.)
- o) Starting Jan 1, each game will have a \$2.00 assigning fee added to it.
- p) MTK team had a big shake-up, all coaches gone, Capitan striped of his C and suspended 5 games
- q) Currently all match penalties showing up as a district hearing when input into TTM. This is not the case play check the ODMHA handbook if you have any.

### 3. Referee Report - Jimm Cluff

- a) All 1st year officials got bumped up to 3 man system (except 13 yr olds)
- b) Supervisions are going well

- c) We tend to lose officials at this time of year because higher level officials do so many games
  - a. Thus, we'll see the same officials more and more until year end
- d) Also the time of year where tempers tend to raise
  - a. Officials and coaches
  - b. If you see a coach wanting an official to talk to them, tell them to walk away
  - c. There's nothing in the rules that say that an official needs to speak to a coach
  - d. Inform Jim if we see an irate official but a calm coach
- e) Next ref meeting
  - a. 3 man system tutorial
  - b. Stress respect you need to give it out...and you'll get it back
  - c. e.g. address coaches as "sir"
- f) Please inform parents never to come to a ref room after a game
  - a. It happened the other night after a Stittsville MM game (a Stittsville parent)
  - b. Jim will be following up with the parent
- g) Another incident
  - a. Parent on player side of JLA not allowed
- h) Jim to invoice association directly for supervisions

#### 4. VP Finance – Chris St. Germain

- a) \$109K in Bank as of Dec. 31
- b) \$200K in investments
- c) RAMS account is \$132K
- d) All accounting is up to date
- e) Have not received an any invoices for Referees...but have paid 32K in advances
- f) Tim spoke to Jimm about setting up a fund next year for Ref skills development
- g) Chris suggested dong it on a reimbursement basis
