#### 1. Call to Order

### 2. D4 + LCMHL Update - Ryan Goodwin

Ryan reported that there have been no meetings for either LCMHL or D4 since our last meeting.

- a) LCMHL- Ryan reported that there was a Presidents phone call meeting to discuss placement + balancing it was decided that everything is good.
- **b)** Ryan reported that on November 1<sup>st</sup> he had a meeting with Beckwith in regards to the Beckwith rink and to discuss a new contract. A new contract was proposed for another 10

years and with 15 hours/week. For the first 2 years of the contract, the rental rate will be \$165/hour – then for the remaining 8 years there will be a 1.75% increase (equal to \$23). We are the first of those associations who have a 10 year contract coming to an end to talk with and renew with Beckwith. If there is any other contracts that do not wish to renew – they will let us know and we may be able to pick up more ice time.

c) Ryan reported there was a well-attended D4 IP meeting lead by Lee Dunbar at the Stittsville Legion on November 8<sup>th</sup>. The new 3 year pilot project that Hockey Canada will be implementing was discussed.

## 3. VP Finance Report – Chris St Germain

Chris reported there wasn't much to report. The association bank account is in good shape, as well as the GIC. Chris is looking for a contact for Quick Enrolment – Patti has offered to help him with this.
