1. Call to Order

Meeting was called to order at 7:00 pm with Ryan Goodwin chairing. *As a result of not having quorum we were unable to do motions or vote. This will be done at our next Executive meeting.

2. D4 + LCMHL Update - Ryan Goodwin

a) LCMHL – Ryan attended the last LCMHL meeting and had the following to report. There was a reminder to timekeepers to make sure game sheets are neat and clear to read. There was also a reminder to coaches to check game sheets, once handed back from referees, to check for any GM penalties – make sure there is a # accompanying the GM. It is best to check and get clarification with any questions or concerns with referees before leaving the rink. Team fees will be remaining the same – at \$100/ team. We have 45 teams – which will equal \$4500 in total. On Goalline, the issue with 1 minute penalties has been taken care of. There will be new game

change and game switch forms brought out for the next season. The new tracking system for penalties is working well. The playoff format will be decided upon in January.

b) D4 – there have been 2 meetings since our last Executive meeting. Ryan reported the following from the two D4 meetings. Denis Dumais has returned to HEO Minor. HEO + HEO Minor have come to a resolution with their differences; HEO Minor is moving back into the offices at Richcraft. HEO has hired an auditor to make sure all finances are in order. There was also a reminder for divisions between Novice – Peewee regarding goalie helmets; these divisions are allowed to wear a player's helmet with a cattle catcher attached. For Bantam - Midget goalies need to wear a helmet with a mask; the helmets can either have a cattle catcher or a point in the bottom of the mask. Referee pays will be late by a couple of days. Changes to Novice will include the division being tiered Minor + Major. Next year ('18-'19) Minor will get ½ ice games and Major will get full ice games. The following year ('19-'20) both Minor + Major will get ½ ice practices. All of these changes come from direction from Hockey Canada. It has been a quiet year so far in regards to hearings; there have only been a couple district hearings involving a couple of Carleton Place players. It involves 3 majors in 1 game – this has been escalated to Hockey Canada for direction.

c) Stittsville RAMS – Ryan reported that our association partnered with the Sensplex in cohosting a Showdown Tournament.

3. VP Finance Report – Chris St Germain

4. Director of Competitive – Chris Weir

Chris reported everything is going well and it's been pretty quiet. There has been one issue with the Major Bantam team involving an issue with a player and their parent. The entire coaching staff resigned. The player received a 10 game suspension. The parent is suspended indefinitely – unable to attend practices or games. A new coach has been put into place. Patti is planning on sending out a survey. Patti would also like to start to look at next season in the new year.

Ryan reported that Rob would like convenors to remind coaches about weather and game canceling - it is not up to the teams to cancel any games; the division statistician needs to be contacted and make the call. Starting at the Peewee level – neither moms nor parents should be in the change room. December 15th is the last day to do game switches. In the older divisions – coaches are reminded to hold their benches at the end of the game until referees call for the handshake.
