2. D4 + LCMHL Update - Ryan Goodwin

- a) LCMHL Ryan would like all convenors to send a note to all coaches that teams cannot cancel games due to bad weather; they need to follow the procedure outlined by the LCMHL. There was discussion regarding the number of penalty minutes in the Midget A games. Referees have been told to reign in games a little tighter. Almonte-Pakenham has very high penalty minutes as a result any GMs and major penalties will be doubled. Overall across the association penalty minutes have been good. We do have a couple of teams over the threshold Peewee A1 and Bantam B1. Playoffs will begin February 20th. The format will be the same as last year for all divisions except Bantam B. Bantam B will be a pilot project with a tournament format; with 30 games in 1 weekend February 23-24. The last game of the season will be held February 13th All games need to be entered immediately to be entered for playoff standings. Playoff information will trickle out in February.
- b) D4 HEO is implementing an IP Coordinator program; our Coordinator will be Lee Dunbar from the Carleton Place association. There will be changes to the referee assigning system, potentially over the summer. The current system League GM is not easy to work with. Referee supervisions are going well we have already doubled the number of supervisions compared to last year at this time. There have been some issues with the Sensplex and the payment of officials. The Sensplex is very slow at paying and so far there is roughly an outstanding amount of \$45,000 owing to District officials. As a result, the District will now be enforcing a 2% late payment fee charge towards referee payment receipts.

3. VP Finance Report – Chris St Germain

Chris reported everything is up to date. Everything is reconciled up to the end of December. Our association gave an advance of \$10, 000 to D4 towards referee payments. Chris wanted to make sure everyone knows that Respect In Sport is NOT paid for by the association. Ice costs could go up 5.6% this year. Insurance has increased equalling \$30, 000 for our association.
