1. Call to Order

2. President – D4 + LCMHL + SMHA Update

- LCMHL / D4 AGM was on Thursday May 9th. A few elections occurred that evening. Tim Sheehan is now the D4 Chair. Glenn Austin was re-elected to Vice Chair D4. Beth Girardi was re-elected to Registrar of D4. Tom Stevens was re-elected to President of Lanark. Shannon was re-elected to VP of Lanark. Treasurer is open currently. If you know anyone, please let me know.
- Novice Hockey SMHA hosted the Novice Town Hall on May 8th. Good representation (40+) from across the D4, Associations and Rockets. HEO, District 9 & 10 attended as well.

Next steps are to put together a Novice Task Force. Within LCMHL Tom would like to have the associations Presidents meet first to discuss the way forward and strategy. Scheduling Ice, number of players on a roster, finding a mutual rink. Sharing the cost of dividers, Etc. 16 player rosters is what D4 agrees with. More to come in next few weeks.

- D4 Penalties are the highest across Ottawa. Need to do our best to decrease these by
 potentially invoking additional sanctions at the district level to bench staff. Glenn will set a
 date for the first meeting and will most likely be in July. Representation from across D4 is
 mandatory. Rob Lomas may represent for these discussions, however Fiona Livingstone
 may be best fit due to connections to her portfolio.
- Coach Selections across district Be mindful of the reason why Coaches Coach. Remind Convenors that we are all here to put our best foot forward to give our families a great Hockey experience. We want the best Coach we can get for the team not just an individual player. When interviewing be prepared, ask others input, don't just select on your own, better to have others input in making these decisions.
- Coaching Clinics Select a few dates on the calendar if we haven't already done so. A lot
 of new coaches at the younger levels. West Carleton had one late last year. Good for our
 association to run.
- Costs for the Tournament Style House B Program for SMHA were \$4,364.
- Start the recruitment campaign. We have open positions across the board. Let's do our best to recruit early so that we are prepared for next season.
- Boundaries Discussion with Shelly Zimmerman Kanata Chair & I are meeting tomorrow night. Should families wish to play in SMHA next year, it will be agreed upon with the approval of both associations.
- Conditioning Camps (House & Competitive) Bantam Contact Camp. Skating & Skills
 Development Camps. Every year parents put together skaters to come out and skate on
 rent ice to get the kids ready for the season. We should be doing this at an association
 level. Would have to ensure insurance (Scott to check), not interfere with RAMS
 conditioning, may be difficult to get ice, could generate extra funds. Fiona to look at ice
 options.

3. VP Finance report

Bank reconciliation for April to be done shortly, then auditing to happen June. Received a \$4300 net bill for B playoffs, he is concerned about the increased cost. We also need to provide reimbursement for referee clinics for new referees. E-transfers now setup for registration. SMHA requires a budget for convenors spending as spending is not consistent. Need to ensure receipts come in earlier next year.
