# 1- Call to Order

# 2-Approval of the Agenda

# 5- President Update

- I will be reviewing the finances with Scotiabank to make sure that we keep bank charges low and the interest high
- I will be holding an audit meeting with the internal audit group in the next few week

#### 7- Vice-President of Operations update

- We will invite our Coach Mentor Mike Roy to the draft nights so that he can introduce himself to the coaches and explain his role
- I will need the Convenors to estimate the number of teams that they will form based on the final registration numbers
- There is a lead at the storage locker leak which will need to be looked at and repaired. If we want to move to a different storage locker, we will need to provide 30 days notice to terminate the current contract

- Carryover suspensions 17, volunteer/coaches will send list to Convenors
- Home tournaments are in the report dates have been blocked out for house tournaments (consider U15B?)
