5- President Update

- Inclement Weather How is it handled? You would have seen a note from Tom (LCMHL) on how inclement weather is managed. Bill Corcoran (SMHA Comms) shared it on our website.

 Under the policies trapped within the League team could face a fine or suspension should

they forfeit on playing a game. Teams can be fined \$75 dollars as per LCMHL policy as well as cover costs to the officials should they forfeit on not playing a game. Over the past few months across the league many games have been cancelled.
